Application for Producer (Vendor) Permit

Permit Guidelines

- The undersigned shall pay \$20.00 for an annual Farm Market Producer (Vendor) Permit if paid by Wednesday May 31, 2023. The fee for a permit if paid after that date shall be \$30.00. This is a per space fee. \$5.00 of this fee will go to the Village of Bellville, and the balance will be used for misc. expenses (advertisements, market enhancements/projects)
- The permit authorizes access to Village property at designated times for the purpose of selling home grown produce (vegetables/fruit), plants and other goods which fall under the Cottage food production guidelines, at the Bellville Farmers Market. There is no guarantee of space availability.
- All producers will have an assigned space for the sale of their items. Spaces will be assigned by the Farmers Market Advisory Committee based on market attendance for the season, previous seniority in the market, and service to the market advisory team.
- All Producers must have a signed permit received and accepted by a Farmers Market Advisory Committee member by Tuesday of the week, prior to set up, and adhere to proper labeling regulations, per Ohio Dept. of Agriculture and Ohio Revised Codes. Failure to do so will prohibit the vendor from selling at that week's market.
- The undersigned agrees not to set up his/her operation before 7:30 a.m. on the day of the Farmers Market, and agrees to be ready for operation no later than 8:45 a.m.
- No vehicles over ¾ ton may be driven or parked on the lawn.
- All setup/selling must be contained in the Village designated space for the Farmers Market.
- Electricity is not available. The sale of live animals and crafts is prohibited
- The undersigned is responsible for disposing of his/her trash. No bags or containers are to be left on the premises. Tents and umbrellas should be properly anchored.
- The undersigned agrees to follow the "Bellville Farmers Market Policy". Failure to do so will ban the undersigned from future markets.

In consideration for issuance of the Permit by the Village of Bellville, Ohio, the undersigned shall pay a minimum of \$20.00 (maximum of \$30.00) per space, to a Market Committee Advisory Member on the date of signing this agreement and further covenants and agrees to waive any and all claims the undersigned, his heirs and assignees, executors, and administrators might incur against the Village and its officers, employees and agents, as well as the Market Advisory Committee for loss, theft, breakage, or bodily injury sustained to the undersigned, and the undersigned, further covenants and agrees to save and hold harmless the Village of Bellville, Ohio, and its officers, employees and agents, as well as the Market Advisory Committee from any and all claims arising out of the operation of any business conducted by the undersigned pursuant to Vendor Permit and to pay all legal fees incurred by the Village in defending any such claims. Any ambiguities herein shall be construed by and in favor of the Village.

This permit is valid for the 2023 Bellville Farmers Market Season.

By signing the Permit Application, I acknowledge that I have read the permit guidelines and the separate Farmers Market Policy, and will abide by each.
